6. **PRIVILEGE OF THE FLOOR/PUBLIC CONCERNS**

- Ike Griswold was wondering if the Highway Department was done mowing along the roads and questions about where they were getting their brine water. Highway Superintendent Schiralli let Ike know that they were not done mowing all roads and there are new laws on where they can get the brine water used on the roads, determined by NY State Pollutant Discharge Elimination System.
- Bill Dibble presented the Board with a proposal to apply for the NYS Safe Routes to School grant. The area he would like to use the grant for is along the highway on Rt. 275, between Richburg and Bolivar. The Board felt this was something needed badly, however there are too many unanswered questions and a deadline of a couple of weeks to have the grant paperwork ready. The board was not interested in moving forward at this time.
