Highway:

- Superintendent Schiralli gave his report to the Board to review.
- Installed a 3ø 20ø extension to a sluice pipe on the south end of California Hollow Rd.
- Replaced all traffic signs, posts and hardware for the breakaway system on Philips Hill Rd and all adjoining roads, Stabb & Putnam. I would like to start replacing signs and posts on Horse Run Road, the laws have changed when replacing existing signs they need to be retro reflective.
- The crew has been patching pot holes, cutting brush and weedwacking around signs, bridges and guard rails.
- They are planning to do ditching on Kossuth Road, and installed a new sluice on Black & George.
- Mark Bearman will start cutting the eight trees in the cemetery next week with help of the Town Highway crew.

10. **OLD BUSINESS**

- Old Garage ó sign building ó The board asked Superintendent Schiralli to bring a list of proø and conø on the buildings he uses to the next meeting so they can decide which ones can come down.

- Councilperson Wittenburg addressed the board with some issues that the pool had again this year. The board would like to have a joint meeting with the Village in February to write a policy for the manager and guards to follow. The Clerk will put it as a reminder in the January agenda to pick a date in February.
- Superintendent Schiralli brought to the board, information on a few mowing tractors. He will be making a spec sheet and putting a notice in the paper for bids to be made.

- The Town has been approached for permission to put links on our website. All were in agreement that this was not something they wanted.
- Dave Thompson from the Bolivar Fire Commissioners thanked the Board for the support they gave during the Southwestern Fireman's Convention.
- The Board has agreed to donate \$100.00 to the Bolivar Methodist Church for the chairs that they gave for the Town Hall office. A motion was made by Councilperson Wittenburg, seconded by Councilperson Iantorno.

- Ed Majot would like permission to use the gravel pit road to access the Pound's land for cutting wood. The Board approved.
