 - Contract GC-3: Global Contracting, Inc.: \$562,762.00 (Includes Base Bid and the acceptance of Bid Alternate GC3-1)
 - Contract EC-1: Concord Electric: \$157,400.00 (includes Base Bid only)
- RESOLVED that the Town of Bolivar Board approves the bids submitted by the Bolivar-Richburg Water Board.
