12. **OLD BUSINESS**

- Councilperson Ingalls meet with Mr. Ball and talked about the Spang building. He gave a rough estimate of \$1,500 for a survey and writing up a property description. The Board Ok'd this as long as this does not go over. Councilperson Ingalls will contact Mr. Ball and see how they are progressing.
- The Board talked about the \$900,000 grant the water district received to replace the bolivar water tank and put in some new lines. This grant came through with the help of CBDJ and Kathy Young's office.
- The Board would like to ask Assessor Luanne Glass to attend the January board meeting to help with the discussion on the reassessment.

- The Board also talked about properties with junk cars. The Board said they need to enforce the laws but will discuss this at a later date.

13. **NEW BUSINESS:**

- The Boiler was inspected and according to the inspector the doorway is too narrow. It needs to be 31 inches. Highway Superintendent Schiralli will take a look at the door and see if taking the door casings off will make the door opening wider.
- The town needs someone to fill in as a Dog control officer until a new one is appointed. Scott Fuller, Town of Wirt DCO, said he would be willing to take on our dog control calls until then. The Board agreed to hire Scott Fuller per diem. Supervisor Gould will call him and make him an offer as to how much to get paid plus mileage. Also an ad has been placed in The Olean Times Herald advertising the position for Dog Control Officer. Applications are to be turned into the town hall by January 4<sup>th</sup> 2016.
- The drop box on the side of the Town hall needs some repairs. It needs a new pad lock and there is also a space between wall and box. Highway Superintendent Schiralli will take a look at the box and try to fix it.
- There are agreements that are about to expire at the end of December or have already expired. The first the agreement the Board reviewed was the shelter agreement with New Hudson. The Board decided would renew agreement as long as Connie Otto does not use shelter. The next agreement reviewed was the Wirt shelter agreement. The Board ok'd to renew as the Board is notified if Dog control officer changes. Then the Board reviewed the lease agreement with Mr. Morrison for the Spang Building. In the original lease, it states that the board could either renew the lease or just allow Mr. Morrison to keep paying month to month. The Board decided to just have Mr. Morrison keep paying month to month.

- The Board reviewed the Teamsters union proposal that was discussed at the meeting with the union representative in November and all members agreed they were ok with what was counter offered. The Board made a motion to approve the Teamsters Union proposal.

On a motion of Councilperson Iantorno, seconded by Councilperson Wittenburg to approve the Teamsters Union Proposal.

Shaner Hill Road from NY 417 to Dead End for a total length of 0.30 miles

- **Justice**: Justice Kirnan submitted his November monthly report to the Board. Check #1028 for \$857.00 was deposited into the General A fund
- **Dog Control**: Dog control officer Connie Otto gave her report for November.
- **Highway**: Highway Superintendent Schiralli gave his report to the Board. He stated in November the highway dept. rented a brush cutter from George & Sweed. The roads that were brushed were Horse Run, Miller Hollow, Mead Hollow, Anderson Hollow, Scott Hollow, Wappsseny, Foreman Hollow, Black & George Hollow, and Beers Hollow roads.  
The guys have been rebuilding the slide in sander for the 99 International. It will also have new bearings, spockett & shafts, sander chain, and floor. It should be done by the 18<sup>th</sup> of December.  
Superintendent Schiralli called Verizon and asked them to move a pole located at the entrance of the Town's gravel pit. Once this is moved, the sluice pipe can be extended so the entrance can be widened and there will no longer be any need to use the Baldwin's property to gain access.  
Mr. Schiralli also had some prices on 10,000 watt generator/welder. The Board ok's the \$3,100 generator as there is still money left over in account. But any other purchases will have to wait until 2016.  
The Board also discussed a possible schedule change that would be more cost effective. Mr. Schiralli will review is and let the Board know.

Mr. Schiralli also discussed 2 of the highway workers who are going to be off due to surgeries. He asked if he could hire part time help. The Board Ok'd the hiring of part time help for the Highway department.
