- Councilperson Ingalls will contact Kelly Lounsberry about moving the sign building as it has not been done yet.
- Councilperson Ingalls will get together with Supervisor Gould to see if they can get the court fax machine fixed. Councilperson Iantorno will also talk to Steve Kirnan.
- Highway Superintendent Schiralli states his department will get the cemetery trees done on a rainy day or during the winter.
- The Bartlett Rd Bridge is now marked with no weight limit. Roy Patterson, an engineer from the county, determined this. The state has not looked at the bridge yet to agree or disagree with Mr. Patterson. New signs are on. In the spring guardrails will be painted.
- Both new hires in the highway department started work on Monday, November 14th.
- Highway Superintendent Brad Schiralli will talk to Supervisor Gould about installing the new drop box.

10. <u>NEW BUSINESS:</u>
