 Water Board at their next meeting.

- Carter black top parking lot black top & restripe parking lot Approve or not approve: Mr. Schiralli will take a look at the parking lot at the Town Hall and let the Board know at the April meeting if he thinks it needs to be sealed again.
- Received Certificate of Insurance for Micah Miller 3/17/17.
- Bud Wittenburg talked to the Board a little bit about the upcoming pool season. The Board received a copy of the letter of interest and a letter of proposed changes from the director applicant. The Board asked Mr.
 Wittenburg to let them know what the pool committee has to say and report back to the Board.

11. Report of Town Officials

• <u>Code Enforcement</u>: 0 building permits issued in February.

• <u>Town Clerk</u>: The Clerk report was handed out to the board. Check#1720 for \$2,689.80 was deposited in the General A Fund. Also issued by the Clerk's Office were 1 temporary handicap permits, and 2 notarized documents.

- <u>Tax Collector</u>: Check #1173 for \$518,041.07 was written 2/1/17 and deposited in General A Fund. Since January 1st March 3rd there has been 20 tax bills paid by credit card or e-check totaling \$25,618.89.
- <u>Justice</u>: Justice Kirnan submitted his monthly report to the Board for the month of February. Check #1051 for \$499.00 was deposited into the General A fund.
- <u>Dog Control</u>: Clerk has mailed "appearance tickets" for anyone that has not renewed their dog license since 12/2016. Board looked at example and agreed to continue as in 3 days there were 35 renewals totaling \$376.00.
- <u>Highway</u>: Highway Superintendent Schiralli gave his report to the Board. He talked about the cemetery trees and drop box in the earlier portion of the meeting.

Mr. Schiralli told the Board about his trip to Albany to lobby for more CHIPS money for the Highway Dept. He said there were 14 superintendents and multiple venders from Allegany County.

The Town has hauled stones to the dirt portion of Anderson Hollow Road, which was then graded.

The Highway Department will be switching to 10 hour days starting April 3rd. They will be working Monday through Thursday 6 am until 4:30 pm.
