- **1.** A Regular Monthly Meeting of the Town of Bolivar, NY was held on, July 24th, 2018, at 6:00 p.m., at the Bolivar Town Hall.

## 7. <u>REPORT OF TOWN OFFICIALS</u>:

• <u>**Highway</u>**: Highway Superintendent Brad Schiralli gave his report to the Board.</u>

Mr. Schiralli informed the Board of the 8 applicants for the open Highway position. The Board requested a copy of the applications and will set up a date to start interviews.

The Board and Mr. Schiralli also discussed a sluice pipe installation policy. The Board asked Mr. Schiralli to find out what the policies are at least 3 municipalities and also from the state and county.

The Board and Mr. Schiralli discussed, briefly, unexcused absences after all vacation, sick, and personal days are used.

Highway Superintendent Schiralli also informed the Board of the ongoing and upcoming projects. These projects include installing sluice pipes for 2 new

builds, cleaning ditches on Horse Run Rd and Phillips Hill Rd, helping the County with shoulder grading and cleaning out a creek on County Rt 40, and helping the Village with a sewer line repair on Prospect St.

- <u>Code Enforcement</u>: 4 building permits issued in July: Heritage Aflame, Salt Rising Rd, wheel chair ramp & remodel apt; Perrin, Rt 417W, install central air; Rockefeller, Mead Hollow Rd, Double wide on foundation; Holmes, Miller Hollow rd., pool & deck.
- <u>Town Clerk:</u> The Clerk report for July was handed out to the board. Check#1792 for \$2,259.69 was deposited in the General A Fund. Check #1793 for \$1,275.20 was deposited in the General B fund. Also issued by the Clerk's Office were 5 handicap permits, and 10 notarized documents.
