• <u>Highway</u>: Highway Superintendent Brad Schiralli gave his report to the Board.

Mr. Schiralli also informed the Board that he will not be renewing the waste transporting permit part 364 for transporting brine water from the Beech Hill facility.

The Horse Run Rd project is now ready for oil and stone. That will be started on Thurs July 26th.

Allegany County is bringing the excavator for the Town to use for a few weeks. Some of the things the excavator will be used for are cleaning up some washout areas, helping the Village with a sewer line, and the pool project. Highway Superintendent Schirallli told the Board that the roadside mowing is still ongoing.
