1. A Regular Monthly Meeting of the Town of Bolivar, NY was held on, October 16th, 2018, at 6:00 p.m., at the Bolivar Town Hall.

6. **APPROVAL OF SEPTEMBER 18th, 2018 MEETING MINUTES**

The minutes of September 18th, 2018, were read by the Board. A motion was made by Councilperson Evingham, seconded by Councilperson Ingalls, to accept the minutes.

7. **REPORT OF TOWN OFFICIALS:**

- **Highway:** Highway Superintendent Brad Schiralli gave his report to the Board.
Mr. Schiralli informed the Board on the projects they have been working on. The Town of Portville let the Town borrow their brush cutter with an operator for a total of 3 weeks. The Town supplied the fuel as Portville supplied the machine and operator. Black and George Hollow and Kansas Hollow were the roads worked on. There are several other roads that still need brushing. Mr. Schiralli asked that for a rental of a brush cutter be included in the 2019 budget.
Highway Superintendent Schiralli also talked to the Board about the benefits of buying an excavator similar to the excavator that is borrowed from the County.
Mr. Schiralli also let the Board know that the new highway employee is in his second week and has been in a truck, driving.

A motion was made by Councilperson Ingalls, seconded by Councilperson Wittenburg, to approve the Sluice Pipe Installation Policy.

- Water board news: Shut offs were this month. 80 letters went out in Sept. and 60 tags were hung. There were 14 properties that were scheduled for shut off on Monday 10/15 but 2 properties paid the full balance right before the water was shut off, 4 could not be shut off due to curb box replacement needed, 1 is an apt building on one box, and 7 were shut off.
- Also, there were 9 Town water customers that had their water bills relevied to the Town & County taxes.

**RESOLUTION 10-2018 APPROVING TO ADOPT THE
ALLEGANY COUNTY HAZARD MITIGATION PLAN**

Whereas, the Town of Bolivar, with assistance from the Consultant TetraTech, has gathered information and prepared the Allegany County Hazard Mitigation Plan; and

Whereas, the Allegany County Hazard Mitigation Plan has been prepared in accordance with the Disaster Mitigation Act of 2000; and

Whereas, the Town of Bolivar is a local unit of government that has afforded the citizens an opportunity to comment and provide input in the Plan and the actions in the Plan; and

Whereas, the Town of Bolivar have reviewed the Plan and affirms that the Plan will be updated no less than every five years;

Now, therefore be it **RESOLVED**, by the Town Board of Bolivar that the Town of Bolivar adopts the Allegany County Hazard Mitigation Plan as this jurisdiction's Natural Hazard Mitigation Plan, and resolves to execute the action in the Plan.

Motion was made by Supervisor Gould, and seconded by Councilperson Ingalls, to approve the resolution to adopt the Allegany County Hazard Mitigation Plan on this 16th day of October, 2018.
