- **Highway:** Highway Superintendent Brad Schiralli gave his report to the Board.  
Mr. Schiralli updated the Board on some projects that the Highway Dept. have been working on. They include, oil and stone surface treatment on Horse Run Rd and Miller Hollow; brushing, ditching, and grading Black and George Hollow; and sand patch pothole repair everywhere. The Board and Highway Superintendent Schiralli went over the possible candidates for a new hire.

Mr. Schiralli also talked to the Board about budget numbers and the possibility of new equipment.

- Sluice pipe installation to private property policy: The Board and Mr. Schiralli discussed the need for a sluice pipe installation policy. The clerk will work on writing up a policy for the Board and Mr. Schiralli to review.
- **Code Enforcement**: 4 building permits issued in August: Ingalls, 7912 Rt 417 W, new manufactured home; Baldwin, Horse Run rd., Double wide; Wedge, 579 S Main St, Deck; Kossuth Community Church, 7150 Kossuth, Remodel.
- **Town Clerk**: The Clerk report for August was handed out to the board. Check #1797 for \$1,688.17 was deposited in the General A Fund. Check #1798 for \$1,172.02 was deposited in the General B fund. Also issued by the Clerk's Office were 4 handicap permits, and 9 notarized documents.
