• <u>Highway</u>: Highway Superintendent Brad Schiralli gave his report to the Board.

Mr. Schiralli updated the Board with the projects that the highway dept. has been working on oil and stoning Anderson Hollow Rd, Mead Hollow Rd, and Willow Brook Rd. There was 171 tons of sand patched mixed for this. He also let the Board know about some work that was done on the back of the Village water tank.

Mr. Schiralli also discussed with the return of the furloughed employee. The Board and Mr. Schiralli talked about the flag at the cemetery. The Town has purchased a flag and will take the responsibility getting the flag up in time for Memorial Day. Mr. Schiralli will also be purchasing a light for the flag. The dept. helped the Town of Wirt for 2 days and Allegany County 1 day with dump trucks, as shared services.

There was 1 burial in the month of June.

Mr. Schiralli discussed with the Board regarding the 99 International truck. The truck was at Portville Truck and has an estimated \$24,000 in repairs that need to be done. The truck has a rusted frame that needs repaired. The current booking value of this truck is around \$40,000.

The Board made a motion to move forward with purchasing a new dump truck.
