Water board news: Supervisor Gould told the Board that there has been an average of 400,000 gals of water being used per day. The water operator is suspecting that there is a leak somewhere as this is more usage than normal. The normal usage is around 150,000 gallons per day. He has hired a leak detection company to come out and check the entire system. The company quoted \$8,000 to come out and find the leaks.
