10. <u>REPORT OF TOWN OFFICIALS:</u>

• <u>**Highway:**</u> Highway Superintendent Brad Schiralli gave his report to the Board. Not a lot to report for this month.

We have been doing a significant amount of plowing and sanding for the past 10 days. Even though we have only had slight accumulations of snow we still have to plow and treat the roads. We have used a great deal of our sand inventory. 3/4 of our sand building has been used. The sand inventory that we had was from last year and what the county has brought us so far this year.

Allegany County Engineer, Tom Windus, looked at the sluice pipe on Kansas Hollow Rd., that needs to be replaced. Tom did a hydraulic study with the maps that he has at the county. He said that we could get away with a 5-ft sluice pipe but highly recommends a 6 ft. If we were to put a 5 ft plastic sluice pipe in, we would need around 24 inches of fill over the top. I'm not sure if we will have the 24-inches of backfill that he is suggesting. I will continue to work with Tom on this project and keep you updated.

Allegany County Surveyor, Robert Langdon, is now finished laying out the 6.2-acre interior surface of the pit that New York State DEC requested. The 6.2-acre area within the pit the Town cannot do any work outside of this area. I have contacted New York State DEC to let them know this has been completed. I'm still waiting to hear back from them.

Mr. Schiralli also updated the Board with vehicle mileage and equipment hours.
