• **Code position questions if Brad Schiralli is appointed:** Mr. Schiralli had some questions for the Board to discuss:

salary for the code enforcement position? use of the town pickup for code enforcement business? schooling and lodging be paid?

Upon Board discussion, the salary will remain the set salary for 2022, the schooling and lodging will be paid for by the Town, as it has in the past, and the Town pickup can be used for code enforcement business.

On a motion made by Supervisor Gould, seconded by Councilperson MacDonell, the Board approved the questions above and Mr. Schiralli. Aye- 5, Nay - 0. Motion carried.

• Stump removal in Maple Lawn Cemetery: There are 4 stumps that need to be removed. Councilperson Majot did receive one quote of \$400/stump. That includes grinding, removal, top soil, seed, and mulch. According to the Town's procurement policy, another quote is needed. Councilperson Majot stated he will work on that.

11. <u>NEW BUSINESS</u>

 <u>RESOLUTION 7-2022 TO APPROVE THE SET DATE TO REPORT</u> <u>DELINQUENT WATER AND SEWER RENTALS TO BE LEVIED ON</u> <u>THE TOWN TAX ROLL TO NOVEMBER 1ST:</u>

On a motion made by Supervisor Gould, seconded by Councilperson Majot, the following resolution was ADOPTED Aye – Gould, Aye – Iantorno, Aye – Majot, Aye – Wittenburg, Aye - MacDonell. Nay – None.

RESOLVED to approve the set date to report delinquent water and sewer rental to be levied on the Town tax roll to November 1st.

- **Police coverage in the Town:** It was brought to the Board's attention that the Village of Bolivar Police Department is frequently asked to respond to calls in the Town of Bolivar. In fact, in 2021 there were 156 calls that the Village officers responded to in the Town. And so far in 2022, there has been 48. So, it was questioned to see if the Town wanted to go into some sort of agreement or contract with the Village Police Dept., to provide coverage for the Town. After some discussion, the Board decided to not pursue the matter at this time, citing mainly that the Town does not have the funding for such an endeavor. However, if any state funding or programs become available, this could be revisited.
- A landowner recently approached Supervisor Gould, questioning about placement of billboards in the Town and wondered if there were any restrictions/laws regarding them. Although the Town does not have any zoning laws, the Board requests that prior approval is made for any billboards along town roadways. Therefore, the Board would approve billboards on a case-by-case basis.

(Regular Meeting September 20th, 2022 cont.)

In this case, the Board did approve the landowner's request to place a billboard up as long as the landowner follows through with his agreement to have his lawyer send over an agreement that states that the content is appropriate.

Motion to approve the requesting landowner's billboard was made by Supervisor Gould, seconded by Councilperson Majot. Aye -5, Nay -0. Motion carried.

A motion to adjourn the meeting at 7:27 p.m. was made by Councilperson Iantorno, seconded by Councilperson MacDonell.
