July 18, 2023

1. A Regular Monthly Meeting of the Town of Bolivar, NY was held on, July 18th, 2023, at 6:00 p.m., at the Bolivar Town Hall.

5. **Guests Present and Public Concerns:** John Krist – Code Enforcement Officer – Mr. Krist was present by request of the Board. The Board asked if Mr. Krist would consider staying on as code enforcement officer. Mr. Krist will let the Board know with an answer by the next meeting.

Mr. Doug Moore – has concerns about the cemetery maintenance and foundations. Mr. Moore stated that the back part of the cemetery does not look good at all. Says grass is very high and weed eating does not get done often. The Board stated they would contact Mr. Putnam and let him know the concerns. Mr. Moore was also inquiring about the timeline of foundations being done after a request is submitted. Mr. Schiralli stated that it usually does not take very long, however, due to the recent flood, the foundation requests were behind. Mr. Moore said he understood.

Mr. Jeff Barnes- Kansas Hill Rd – Mr. Barnes was in to inquire about the Kossuth Rd and if there will be another coat of oil and stone done. Highway Superintendent Schiralli stated that the next coat is scheduled for Sept. Mr. Barnes also asked about the Town putting a stop sign at the end of Olive St, before Kossuth Rd. Mr. Schiralli will look into what it would need to happen, local law, etc., to place a stop sign.

- **Highway:** Highway Superintendent Brad Schiralli gave his report to the Board.
Monday July 17th and Tuesday July 18th - Cold mix paving Olive St. and Kossuth Road.
We will also be paving a portion of the McKee Road.
Plan to pick up the airflow stainless steel truck box we are purchasing from New Albion township the week of July 23rd.
Other road projects we have been working on are.
Roadside mowing.
Grading and cutting shoulders.
Still working on cleanup from July 3rd flooding on Kansas Hollow, Foreman Hollow, and Bartlett Road.
I would like to revisit the purchase of a brush cutting head for our excavator possibly for next year. I talked to Wayne from the village, and we could possibly do a shared service purchase? The village of Bolivar has maintenance agreement with New York State DEC on Root creek, (Little League Field to School) so this would benefit the village of Bolivar as well.
Spoke with New York State DOT Bill Mullen about the flooding issues caused by the sluice pipe plugging above the pool. It seems New York State DOT will be willing to help us out with this project. We may need to consult an engineer to do a study on what size pipe to

handle the capacity of the water runoff that keeps flooding the residents below. The town has dug back the opening of the sluice pipe and cut it off. It was bent and mangled due to equipment trying to unplug this pipe on July 3rd.

Truck mileage and equipment hours were also provided to the Board

- **Code Enforcement**- No report for June submitted. 3 permit applications; Feely, Michael – 968 Coyle Rd – replace porch & add roof; Cobado, Kent – 1398 Kansas Hillw – 10x58 cover to back of house; Freiermuth, Terry – 815 Kansas Hillw – 14x30 prebuilt cabin.
- **Town Clerk**: The Clerk report for June was handed out to the board. Check #2050 for \$5,273.06 was deposited in the General A Fund. Check #2051 for \$200.00 was deposited in the General B Fund. Also issued by the clerk's Office were 3 permanent handicap permit and 2 notarized documents.
