March 21, 2023

1. A Regular Monthly Meeting of the Town of Bolivar, NY was held on, March 21st, 2023, at 6:00 p.m., at the Bolivar Town Hall.

5. **Guests Present and Public Concerns:** Larry Bedow – Town of Wirt Board member - Came in to ask the Town of Bolivar to reconsider the Town of Wirt's request to be tax exempt on property recently purchased in the Town of Bolivar. Supervisor Gould explained that the Town of Wirt does not meet the criteria to be tax exempt for that property. Mr. Bedow stated that it was the Town of Wirt's understanding that the Town of Bolivar could, by written request, make it tax exempt. Supervisor Gould said that he would check with that county and the Association of Towns, to see if it is possible.  
Bob Mead – BRAG Historical Society – BRAG is looking for a space to store the historical records and a place to have their meetings. Mr. Mead asked if the big room upstairs could be used. Supervisor Gould said that the Town would have to check with the insurance company for any liability issues. The Board will have to discuss this more, as the upstairs is used by the Village and Police Dept. as well.

**9. REPORT OF TOWN OFFICIALS:**

- **Highway:** Highway Superintendent Brad Schiralli gave his report to the Board.  
The 2023 construction season is already starting to get underway. Rumor has it there will be a shortage of 1-A stone this year. We use 1-A on all our oil and stone jobs. There really is not a substitute for this size material. All of the local plants have already been sold out for this year. This leaves us with the same option we had last year, and that will have to haul all of our 1-A from Dolomite plant in Leroy. I'm currently working on pricing from Dolomite in Leroy. Here is what I have so far.  
FOB. \$18.00 ton  
Delivered to us. \$31.00 ton  
Supervisor Gould did the math and it would cost the Town at least \$28 per ton to pick up compared to having it delivered for \$31 per ton.  
The Board also talked about using limestone instead of 1-As.  
I went out with Midland Asphalt last Wednesday to measure up what we have plans to resurface. Nick has not gotten back to me on any of the pricing yet. I called him today and he has been very busy so he just gave me a generic per mile material and price estimate. Everything seems to be up in price this year, so we probably won't get as far this year as we have in past years with resurfacing. Nick from Midland Asphalt said that oil will be taking a huge jump in price around June. My plans are to get started early so that we can avoid the increase in price. This can be one of the topics up for discussion at tonight's board meeting.  
Per mile material and price list  
135 tons of 1-A per mile.  
4700 gallons of oil per mile. The current price per gallon now is \$3.49.  
Estimated cost per mile for oil and stone is right around \$20,611. Single course treatment.  
Dog kennel. We currently do not have a hot water tank in the dog kennel.  
I have not gotten to hook up a low temperature warning device for the dog kennel yet.  
The price for a 60 ft long by 60-inch plastic sluice pipe is going to be \$8,238. This pipe will be installed on the Kansas Hollow Road, replacing one that is in very bad shape.  
The Town of Angelica has a pro 2500 salt dog poly conveyor chain spreader for sale. A new one of these salt dog spreaders same model is around \$7,300. This one that they are looking to get rid of has only been used for one season and they will be asking \$6,000. Looking for the boards input.  
I have a price quote for a garage door opener. I know we tossed the idea of getting one opener per year.

Mr. Schiralli also provided truck mileage and equipment hours.

- **Code Enforcement**- No report for February submitted.
- **Town Clerk**: The Clerk report for February was handed out to the board. Check #2033 for \$730.00 was deposited in the General A Fund. Also issued by the clerk's Office were 5 permanent and 1 temporary handicap permits and 2 notarized documents.
