Allegany county had supplied us with their sod loader machine along with an operator. We use this machine for 4 days. We had pulled the shoulders with our grader into the roadway, and then loaded it into dump trucks with this machine. The town had worked on the entire length of the horse run road, then went to the Phillips Hill Road to complete it. Using the sod loader and asking other townships for help, with use of their trucks, we can load out a lot of shoulder material in a short period of time. Most all this material that we pulled from Horse run Road went to our gravel pit to use for reclamation of our gravel pit.

We mixed around 40 tons of sand patch to use on some of our roads to patch out. We had Suit Kote come and do the mixing.

We ditched and graded the entire length of Putman Road. Adding almost 100 tons of crushed bank run gravel to the roadway.

We started working on Beers Hollow Road. Cleaning ditches, adding crush Bank on gravel to the roadway, grading and rolling. So far on Beers Hollow Road we had used approximately 180 tons of crushed bank run gravel.

We ordered a new Salt Dogg poly sander, model 2000x. The sander will go on the 1-ton Ford dump truck. This sander will be delivered on Wednesday November 22nd.

I have prices on three different, one-ton dual rear wheel dump/plow trucks. We need to decide on ordering this to fall within the 2024 budget. The lead time on getting this truck may be up to one year. The cheapest quote we received is from Cappellino Chevrolet, which is the same dealership we purchased the one-ton single wheel truck from. We can ride on an existing mini bid to purchase this truck.

A motion was made by Councilperson Iantorno, seconded by Supervisor Gould, to approve to place an order to purchase a 1-ton dump/plow truck from Cappellino Chevrolet, once the order bank opens.

I have been entertaining the thought of not putting the stainless-steel box that we had purchased on the 99 International dump truck. My thought is to put this on a new cab and chassis along with the plow equipment from 1999 International. This has the potential to save about \$100,000 versus purchasing a new truck with new box/plow equipment on it. Then have somebody like Valley Fab convert everything over to the new cab and chassis. Current new plow dump trucks are pushing the \$300,000 mark. The cab and chassis will run \$150,000, the plow equipment, and dump box is also in the ballpark of \$150,000. Just food for thought we can discuss it at tonight's board meeting.

Mr. Schiralli updated the Board regarding the damage to a road. The town Attorney suggested that the Town file a claim with the insurance company. Mr. Schiralli contacted the insurance company and stated that the town roads are not covered but will pursue a claim with the insurance company of the person who did the damage. Truck mileage and equipment hours was also reported to the Board.
