10. OLD BUSINESS:

- Cemetery Maintenance agreement Board will wait until closer to bid time to look at changes for the agreement.
- Town lawyer Board will look into this.
- Sluice pipe policy update: The Board discussed policy changes. The new updated policy will be available for approval at July's meeting.
- Whole town re-evaluation: Supervisor Gould spoke with Assessor Bobbi Elderkin and states that she agrees that it is time for a re-evaluation of assessments.
- Sluice pipe on Kansas Hllw at Sikorski- Supervisor Gould stated that the Allegany County Highway Dept. did get back to him in regards to this and told him that there is not a threat to the road if nothing is done on the property of the Sikorski's. States that there is not a need for the Town to do the replacement and work on the private property. Highway Superintendent Schiralli stated that he agreed. Mr. Gould or Mr. Schiralli will reach out to the property owners.
- Stop sign & speed limit on Kossuth- Speed limit signs have been ordered and arrived. One for 35mph and the other 40mph, will be added to the current zones accordingly.

11. NEW BUSINESS

- **Host agreement:** Supervisor Gould asked the Allegany County Industrial Development Agency to send over an example of a host agreement. This host agreement is for if companies that have wind turbines, solar farms, etc. and want to put them in the Town. With this agreement, the Town can negotiate a rate to charge the company for "hosting" their services. The Board will discuss more at the July meeting.
